Mi querido Dr. Lloyd,

Le estoy enviando una carta acabada de recibir del Arzobispo de Jamaica con una copia de mi contestación. Agradeceré profundamente si usted pudiera ver al Sr. Pratt para discutir este asunto con él y entonces me gustaría que usted presentara esta carta y su respuesta al Comité sobre Poblaciones de Habla Extranjera, de tal forma que ellos puedan examinarlas y tomar la mejor acción, considerada prudente en la próxima reunión que la Junta celebrará el día 13. Por su puesto, la carta levanta un asunto muy importante y yo no sé cómo podemos llegar a un acuerdo a menos que el Arzobispo cese su petición. Si él no retira su petición no veo que ninguna otra cosa pueda surgir de esto, salvo que el Obispo Presidente retire la comisión que le ha dado al Obispo de Sacramento, y de que notifiquemos al Capellán Brown y al Sr. Caunt que por el tiempo presente descontinuosmos los planes para el trabajo en P.R. También me interesa saber, si a juicio del Comité, y bajo las circunstancias, si no se le debería aconsejar al Obispo Presidente de que éste se comunique con el Obispo de Sacramento para dejar sin efecto su nombramiento para visitar las Iglesias en este lugar.
