Dear Bishop Ferrando:

I was a bit confused this morning and am afraid that perhaps through my own stupidity I may have failed to have understood exactly the problem that you put before me. Hence this letter.

If what I put down here is a correct interpretation of what you said, just write that it is correct and sign your name on this sheet of paper and it will save us both trouble.

As I understand it the Episcopal Church has not received and taken title to a good bit of the property at Quebrada Limon.

What you wanted to know was whether the title to the property should be transferred to Bishop Colmore as the Bishop of Porto Rico or to the Domestic and Foreign Missionary Society as the legal corporation which holds property for the Episcopal Church.

And I told you this morning that it would be best to transfer title for the Quebrada Limon property directly to the Domestic and Foreign Missionary Society.

I am sorry to be so stupid and to be uncertain about the mat-
